I hereby further affirm and agree to the following:

I agree to waive, release, indemnify and hold harmless and forever release and discharge each of the Saint John's Retreat Center Parties for any and all claims, demands, injuries, damages, actions or causes of action, suits, obligations, debts, judgments, remedies, or liabilities of any nature, and from all acts of negligence arising as a result of, or otherwise in connection with or related to, my stay and participation at Saint John's Retreat Center, any activities on the Saint John's Retreat Center properties, or any activities incidental thereto, wherever, whenever or however the same may occur, which may be made by me, my successors, family, estate, executors, heirs or assigns.

I agree that the Saint John's Retreat Center Parties shall not be responsible for any bodily and or physical/mental injury suffered by me as well as loss/theft of property during my stay at Saint John's Retreat Center for any reason whatsoever including participation in activities (on and off the premises), using equipment or receiving services and treatments, including, without limitation, ordinary negligence on the part of any Saint John's Retreat Center Party.
